That said municipal corporation shall restore said described land to a satisfactory condition after construction and/or maintenance in substantially the same condition as prior to entry.




- 4. Grantor understands and accepts that the easement will be used by members of the general public as part of their use and enjoyment of the overall <u>Indian Creek Trail</u>.
