

Linn-Mar Community School District Statement of Equity & Inclusion

Read by Board President Brittania Morey during the December 13, 2021, school board meeting.

There have been ongoing discussions surrounding diversity, equity, and inclusion within our school district. To have members of our community, our own students, state that they feel harassed or marginalized due to their race, gender, sexual orientation, or beliefs is hard to hear. At its core, Linn-Mar believes that every student should feel welcome and respected by all who surround them. The fact that this is not the case is simply unacceptable.

Creating a safe learning environment that feels welcoming and accepting to all our students is a top priority for this board. Without this environment students cannot achieve at their highest levels.

There is no easy fix for division and the feeling of not being accepted. As a district we must start with this truth in order to truly begin to move forward. This is the goal the board outlines today.

We recognize that the past 20 months have not been easy for anyone. We also recognize that events surrounding social justice, race relations, and income disparity have long plagued our society. It is important for all of us to understand that our students watch and listen. They engage and are not as isolated from current events as students have been in the past. While it seems these events of turmoil happen far from our boundaries, the impact occurs within the halls and walls of our buildings.

In recent weeks our students, representing different viewpoints, stood up and walked out. They expressed their constitutional right to free speech, and highlighted areas of discord and misunderstanding. The board is here to state to these students, to all of our students, that we are listening. We are also listening to concerned parents and community members, and we are listening to our teachers and staff members as well. We hear you and we are committed to working with you to bridge this divide and bring our community together.

This fall Linn-Mar began an Equity committee comprised of community members, staff, parents and students, and a representative of this board. This committee has met regularly and will be outlining steps the district can take to address areas of concern in our district. These discussions are helpful for us to understand the lived experiences of underrepresented students and to chart a path forward.

In addition to this new committee, the high school administration, in collaboration with district leadership, is working on a series of steps to work with students, both our student leaders and our entire student body, to address the division being felt in our hallways. Ongoing student engagement to address inclusiveness and the sense of belonging in our buildings, as well as shifts in policy and procedures will follow. We also understand the concerns being shared by parents and while we cannot always share every detail of evolving situations, we value parent communication and take each concern into account as we review and update district policy and procedure.

The Linn-Mar school board has set policy in place, in accordance with state and federal law, that protects and affirms students' rights to free speech and expression. We will continue to uphold those rights but also work with students to understand the impact on other students and the community, and to work toward a wider understanding and acceptance of our differences. We will also work with our students to help them see there are more similarities than difference between them.

Rest assured, these efforts are something the school board, administrators, teachers, and support staff at all district levels are taking seriously. As members of our district, whether you are a student, parent or guardian, staff member, or member of the community, you also play an important role in this process. Your continued assistance in supporting and helping create a safe learning environment for ALL students will be critical to our success.

Even with these initial steps, we know this will take time, and continued conversation. Moving forward, we are committed as a district to a path of continuous improvement efforts in the areas of diversity, equity, and inclusion.

Ultimately, the work of creating a respectful, unified, and inclusive environment is never "done." This work must be active and intentional and evolve as we learn and grow. It takes all of us coming together for authentic conversations with a shared goal of creating spaces where ALL students can be their best selves.

Together, we will continue to build a school culture of which we can all be proud. Because together we are stronger. Together, we are Linn-Mar.













Planning Exercise Summary







Performance Venue

Each group located the blue block at the west side of the high school directly south of the existing performing arts entrance.



Indoor Activity Center

4 of the 5 groups placed the red block on the east side of the high school north of the existing gymnasium.



High School Extension

Each group placed the green block within the southwest quadrant of the high school site. Two groups also suggested a new building for the administration located off Winslow Road, east of Excelsior Middle School.



Parking

Parking is a premium at the high school site and yellow parking space blocks were shown throughout representing the general opinion to maximize it as much as possible.



Tennis Courts

Multiple groups suggested to relocate the tennis courts off site from the high school. Suggested locations include the Oak Ridge Middle School athletics area, and to the north near Excelsior Middle School.

Linn-Mar Community School District CTE Advisory Committee December 1, 2021 LRC Room 304/305 4:15-5:45 pm



The Linn-Mar Career and Technical Education Advisory Committee met on December 1st in LRC Room 304/305. Board President Sondra Nelson, and Board members Matt Rollinger and Melissa Walker represented the Linn-Mar School Board. Primary activities for the session included new learning about LMHS CTE programs and activities and review of information related to the programs past Comprehensive Local Needs Assessment (CLNA). Current program performance was examined relative to Perkins grant funding goals and priorities for the past year.

Sheryl Bass, College/Career Transition Coordinator for Linn-Mar High School, Kirkwood Community College, described her new role working with at-risk, underrepresented, or underserved LMHS students, with a goal of making possible student transitions to high reward opportunities for college and career.

Chris Patterson, Design Engineering, and Materials (DEM) teacher for Linn-Mar High School reported on the regional Career and Technical Service Organization (CTSO) Kickoff event held in early October. The State of Iowa has mandated that all service areas in each school operate a co-curricular CTSO beginning in the 2024-2025 school year. Linn-Mar currently has CTSOs for Agriculture Science (FFA) and Business (FBLA), and will need to initiate new CTSO programs for Design Engineering, and Materials (Skills USA or TSA) and Family and Consumer Science (FCCLA).

Dana Lampe, Linn-Mar High School Innovation Coach reported on a Professional Development Day visit by fourteen LMHS Career and Technical Education teachers, teacher leaders, and coordinators to the Waterloo Career Center. The Waterloo Career Center is a state-of-the-art facility serving Waterloo CSD schools. The Career Center offers programs for Advanced Manufacturing, Biomedical Lab Technician, Culinary, Digital Graphics, Digital Interactive Media, Early Childhood Education, Electrical, Emergency Management, Entrepreneurship/Finance, Health Careers, Hospitality/Tourism, IT-Web Programming/Development, K-12 Educator Preparation, Marketing, Plumbing, and Sustainable Construction. The goal of WCC is to give students the opportunity to explore careers with hands-on experiences helping them develop a competitive advantage to live the lifestyle they want. A driving strategy was to work directly with professional organizations, businesses, and industry partners to access real-time, industry-need-based learning for students.

Service area teams (BUS, DEM, FCS) provided quick reports on recent activity and upcoming events.

State-level approval was acknowledged for our District's Perkins (\$57,814) and Regional Planning Partnership (\$8,345) grant applications. Perkins money will be used to upgrade or purchase new industry-standard equipment in all service areas. RPP money is designated to be used for professional development and/or additional training of CTE teachers.

The Committee concluded the meeting by dividing into service area teams to examine program performance relative Perkins to grant funding goals and priorities for the past year. Priority actions for LMCSD CTE include:

- 1) Alignment of LMHS CTE programs to local needs and ensure exposure to emerging occupations, and review of workforce and economic data annually to respond to changes in the labor market and develop new or refine existing CTE programs,
- 2) Promotion of CTE programs to include both general and special populations (TAG, students of color, and low-SES are currently underrepresented), and
- 3) Improvement of student and staff safety through improved staff training and updates in tools and machinery.

Committee time was limited, and program review will continue with the next Advisory Committee meeting on Wednesday, February 22, 2022.
