Section 1. The sale of approximately \$15,000,000 School Infrastructure, Sales, Services and Use Tax Revenue Bonds, Series 2023, to be dated the date of delivery, for the purpose of providing funds to construct, furnish and equip a new Learning Resource Center, upon the following terms, is approved and confirmed.
